Endorsement of 2016 Work plans and Budgets

Purpose

This paper presents for System Council review, and if considered appropriate, endorsement of the 2016 work plans and budgets for the ISPC, the IEA and the CGIAR System Organization pursuant to the functions of the System Council set out in Article 6.1 (u) of the CGIAR System Framework.

Recommended Decision Point

1. Based upon the discussion below, the System Management Office puts forward the following as the proposed decision of the System Council in respect of the 2016 work plans and budgets for the System Council's advisory bodies and the CGIAR System Organization.

The System Council

<u>Endorses</u> the earlier Fund Council decisions to approve the 2016 budgets and related work plans of the following CGIAR System entities:

(a) CGIAR System Organization: US\$ 7.25 million;

(b) ISPC: US\$ 3.88 million(c) IEA: US\$ 2.48 million

Background

2. The Fund Council, at its 14th meeting of 4 – 5- November 2015 approved 2016 work plans and budgets of the Fund Office, Consortium Office, IEA, Trustee and ISPC for ongoing normal operations upon the recommendation of the Fund Council's Peer Review Team¹ in the amounts set out in table 1 below.

A decision taken by the Fund Council at its 15th meeting of 5 – 6 May 2016 in regard to the transfer of costs from the Fund Office to the Consortium Office to contribute to the cost of the 1st System Council meeting and related events³, results in a final approved 'Consortium' budget of US\$ 7.25 million for 2016.
